Mission Statement:

Christian STEM Education Group (CSEG) is dedicated to glorifying God through a Christ-centered homeschooling community that fosters spiritual growth, academic excellence, and mutual respect.

1. Biblical Values and Behavior

- Christ-like Conduct: Act with love, kindness, and integrity (Colossians 3:12-14). Interactions should reflect the fruits of the Spirit (Galatians 5:22-23).
- **Integrity**: Act honestly and uphold biblical standards in all dealings, including communication, commitments, and responsibilities within the group (Proverbs 12:22).
- Language: Use speech that is edifying, avoiding gossip, slander, profanity, or any language that dishonors God or others (Ephesians 4:29).
- **Conflict Resolution**: Resolve conflicts biblically, seeking reconciliation (Matthew 18:15-17).
 - If conflict occurs, first speak directly with student.
 - If conflict occurs again, speak with parent(s) and have them sit in class with student.
 - If conflict is still not resolved, ask student to leave class for the day.
 - If conflict still exists, student may be asked to leave the program.
 - If a student is asked to leave the program no refund will be given, so please prayerfully consider if CSEG is right for your family.

2. Respect for the Community

- **Respect**: Welcome all members, respecting diverse homeschooling approaches (Romans 14:13).
- Safety: Ensure safety by following group policies and reporting concerns.
- **Stewardship:** Treat facilities and belongings with care (1 Corinthians 10:31).

3. Participation and Responsibilities

- Active Engagement: Engage actively, fulfilling roles diligently (Colossians 3:23).
- **Punctuality and Preparedness**: Arrive on time and prepared.
- **Supervision of Children**: Parents are responsible for supervising their children during weekly programs, ensuring they follow the Code of Conduct and respect property, peers, and adults.

4. Academic and Spiritual Commitment

- **Support for Homeschooling**: Encourage one another in the pursuit of academic excellence and spiritual growth, sharing resources and ideas to strengthen each family's homeschooling journey.
- **Faith-Based Focus**: Incorporate biblical principles into group activities, such as classes, field trips, or social events, to nurture faith in students and families.
